(Delegates who prefer a classroom based course are welcome to attend any of the 2-day courses as above).

RSPO P&C Lead Auditor Refresher Courses.

These courses will be days 2, 3 and 4 of the above full 5 day RSPO P&C lead auditor courses.

It is an RSPO requirement that all RSPO P&C auditors who are qualified to be either a lead auditor or to be a member of an RSPO P&C Audit team, in accordance with the RSPO P&C Systems – June 2017, complete an RSPO endorsed P&C Lead Auditor Refresher Course every 3 years. (RSPO P&C Training Syllabus – November 2016).

Note: The official RSPO document “Principles and Criteria Training Syllabus 10th November 2016” as published on the RSPO web site, allows refresher courses to be given either as a webinar or as a classroom training. The duration of the training is officially 16 hours but CheckMark Training have taken the exclusive decision to combine the two options and to extend the duration to ensure highly effective and up to date training for qualified lead auditors.

Delegates will be required to study both pre-course reading material and narrated powerpoint presentations prior to attending 2 additional days of classroom study and the practical day of on-site auditing.
