

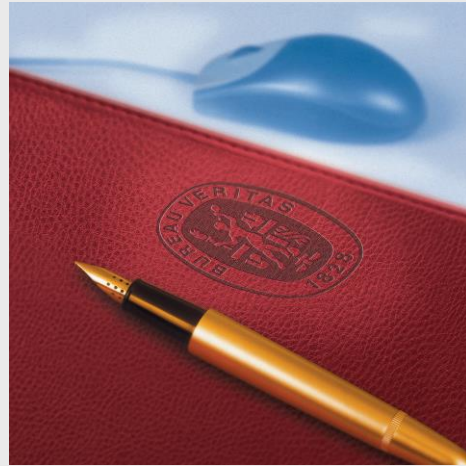

Roundtable on Sustainable Palm Oil

Overview

For many years, consumers in Europe and the USA have required companies to ensure and demonstrate that their operations do not result in any negative social and environmental impact.

The Roundtable on Sustainable Palm Oil was established in 2004 with the vision to transform markets to make sustainable palm oil the norm and to promote the production and use of sustainable palm oil for the people, the Planet and prosperity.

Today, market requirements regarding the origin of sustainable palm oil are becoming stricter especially in consuming countries in Europe, the USA and Australia, and the global demand for vegetable oil from sustainable origin is growing fast. As of late 2012, 14% of palm oil globally was certified under the RSPO certification scheme and this continues to grow fast.

To show their commitment towards sustainable development, environmental and social issues, and to improve the reputation of their organisation, owners and managers of palm oil companies can choose to engage in the RSPO certification process and produce certified palm oil.

RSPO Supply Chain Certification

Overview

In order to achieve RSPO Supply Chain certification, companies will need to establish a chain of custody system to track the certified palm oil throughout their production process, from their suppliers to their customers. The RSPO has developed a number of different options for companies who want to become RSPO certified in order to trade and promote RSPO certified sustainable palm oil.

This BUREAU VERITAS RSPO Supply Chain training course has been designed for participants to gain a thorough understanding of:

- Context of the Palm Oil sector and how it operates,
- Key sustainability challenges faced by the Palm Oil Industry,
- The Palm Oil supply chain from the plantation to the end user
- RSPO supply chain certification requirements,
- RSPO Principles and Criteria
- RSPO supply chain standards, including the different supply chain models
- RSPO Unit of Certification
- RSPO trademark requirements,
- RSPO RED requirements,
- RSPO supply chain auditing procedures and certification process,
- Practical examples and exercises.

COURSE PREREQUISITE FOR RSPO SCC LEAD AUDITORS

A 2 day course designed for auditors and all companies in the supply chain; from palm oil mills to retailers; who purchase, process, manufacture and sell products containing palm oil and palm kernel oil and their derivatives. It is applicable for all sizes of business, managers at all levels, internal auditors, third party auditors and certification body personnel.

It is an RSPO requirements that RSPO SCC lead auditors have the following qualifications prior to attending the 2 day course:

- Successful completion of a recognized lead auditor course e.g. a ISO 9000/19011 lead auditor course.
- Field working experience in similar supply chains, or equivalent related to and as necessary for the certification process.
- A supervised period of training in practical auditing by a qualified lead auditor with at least 15 days audit experience in similar certification schemes (i.e. including traceability), achieving a minimum of 2 audits at different organizations.

COURSE OBJECTIVES & LEARNING OUTCOMES

The participants to the **BUREAU VERITAS Training for RSPO SCCS LEAD AUDITOR** will be based on a detailed presentation of all RSPO SCCS lead auditor certification requirements and related procedures.

By the end of this training, participants will achieve a thorough understanding of the context in which the palm oil sector operates as well as the following topics:

- Understanding the origins of palm and kernel oil and the complete supply chain.
- Understanding accreditation, certification and auditor qualifications.
- Understanding the supply chain models and associated modules.
- Understanding the audit requirements for each model.
- RSPO claims and the use of the RSPO Trademark and Logo.
- Document templates and audit reports.

By the end of the training, all participants should achieve a thorough understanding of the different RSPO requirements and related certification process, as well as the context in which these certification requirements and procedures have to be implemented.

Finally, at the end of the training participants will need to demonstrate their understanding of RSPO certification through a written examination. Candidates who successfully pass this examination will be awarded a Bureau Veritas RSPO SCC Lead Auditors Certificate.
